New Renewal Business Membership Dues \$450.00

Business membership are required for entities that employ 2 or more captains and/or more than 3 mates. Included in the dues are memberships for up to 2 captains and up to 3 mates and an administrative fee. Additional captains can be added at \$85 each and additional mates for \$40 each. Once a membership application is accepted for an employee, they remain in one of the slots for the remainder of the calendar year. Individual Captain/Mate applications are required to be submitted in addition to this application. Pre-employment testing (if required) is \$50 per employee. Pre-employment testing fees are non-refundable.

The undersigned applicant agrees to have employees participate in the ELECBA Random Drug Testing Consortium in accordance with the Department of Transportation, United States Coast Guard, 46 CFR Part 10, Chemical Drug Testing Programs for Commercial Vessel Personnel.

All drug testing/consortium activities are performed by those meeting CFR requirements. As a condition of acceptance of applicant's enrollment in the ELECBA Random Drug Testing Consortium – and in full satisfaction of USCG requirements for the establishment of a random testing program intended to provide a reasonable deterrent to workplace drug abuse - consent is hereby given for the program's Medical Review Officer to concurrently report applicants verified POSITIVE drug test results, if any directly to the applicant and USCG District MSO.

This period of consent shall coincide with the period of applicant's enrollment in the ELECBA Random Drug Testing Consortium and may be withdrawn at any time upon delivery of applicant's written notice to the ELEBA.

***If you are working, you must be subject to random testing. In accordance with the Code of Federal Regulations Title 46, Part 10, § 16.210 Pre-employment testing requirements - All New Applicants must either provide proof of current membership in an approved drug consortium or submit to a Pre-employment Drug Test. In addition, any member that has not been subject to random testing during the previous 185 days for least 60 days will be required to take a pre-employment test. Pre-Employment Drug Test that Test will be \$50.00 additional.**

For Drug Testing must use a designated testing facility with an ELECBA provided bar code. Use of non-designated facilities can result in additional charges to the member.
